Where do you currently live?

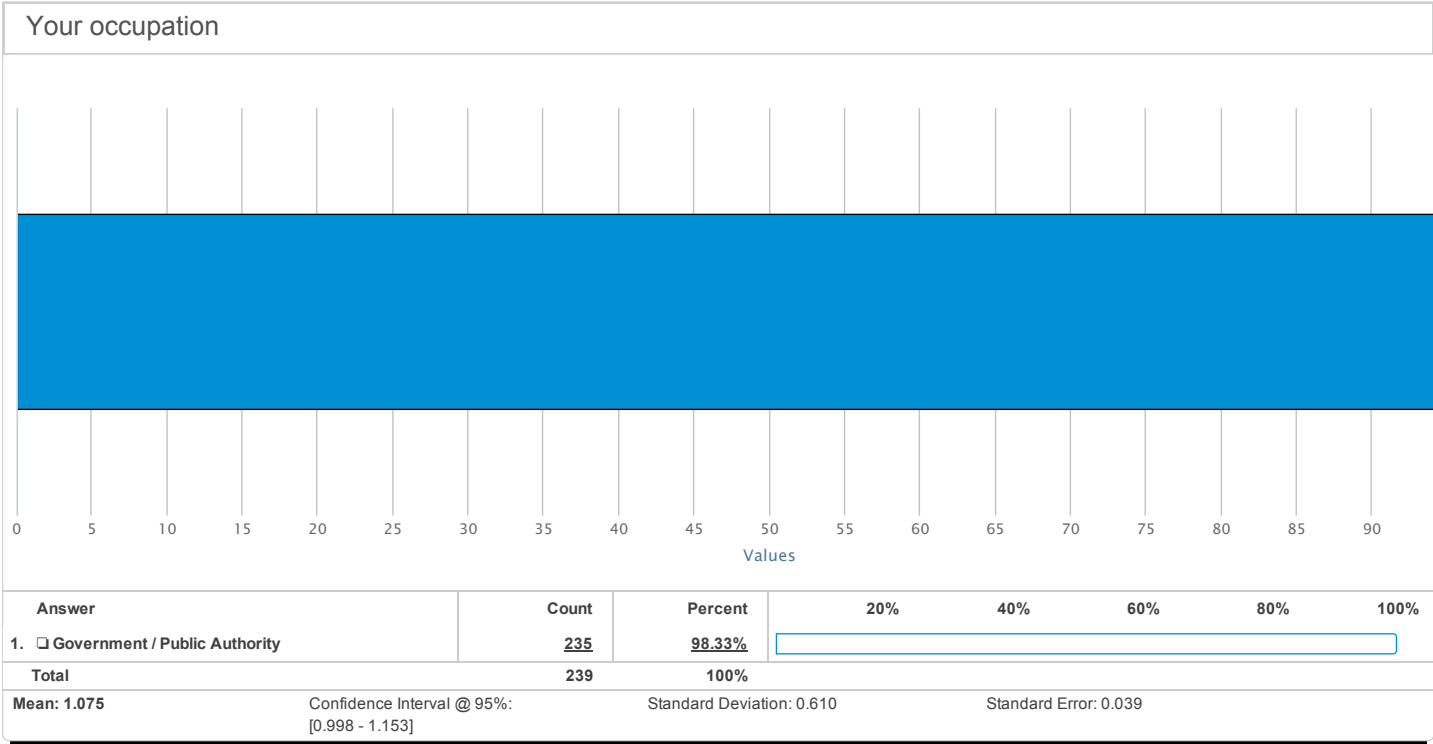

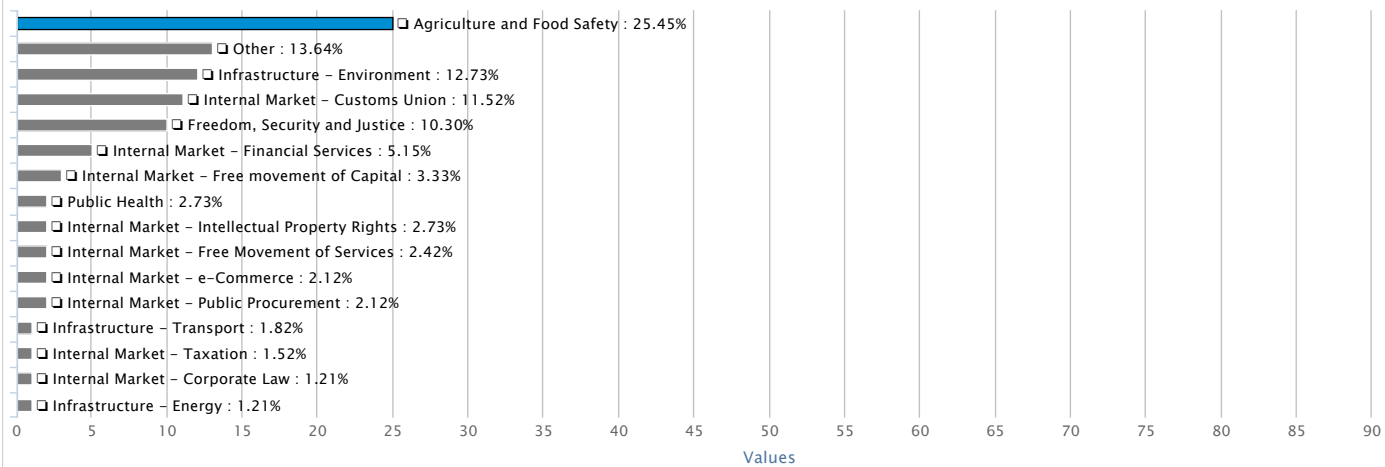
Your role in the TAIEX

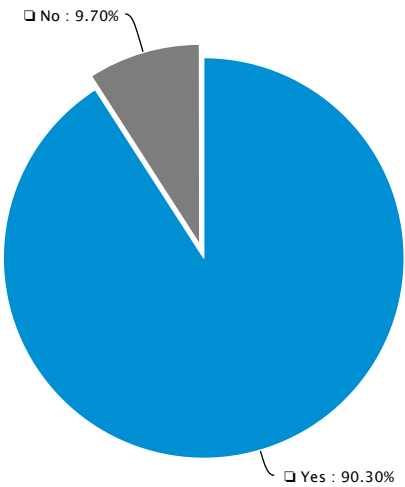


Which of these TAIEX areas (or EU Acquis Chapters) do you deal with?



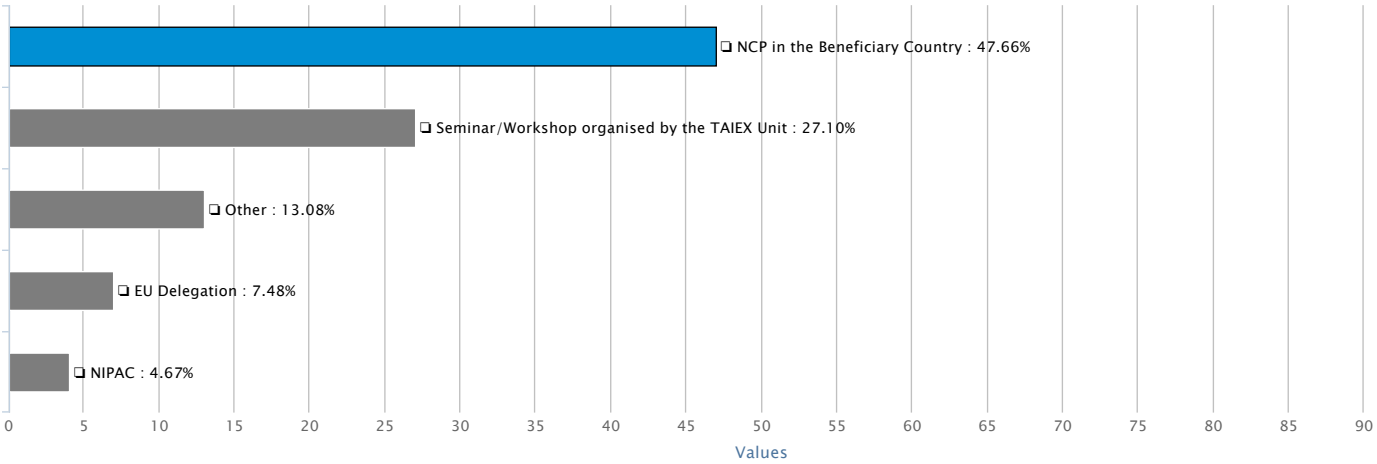

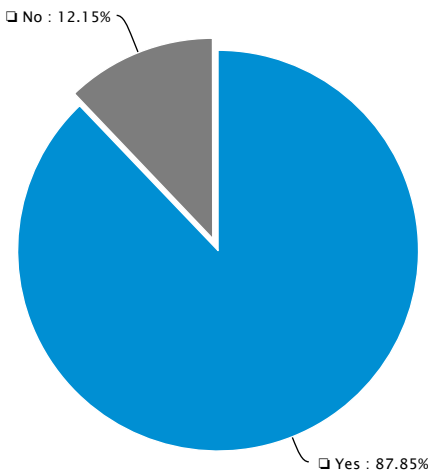

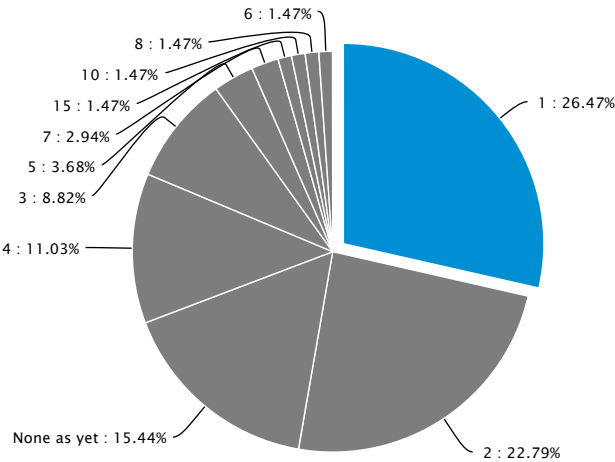

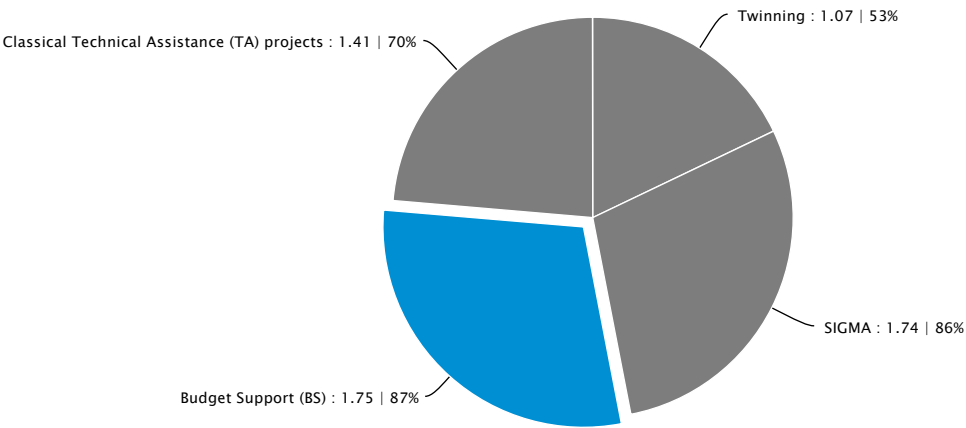

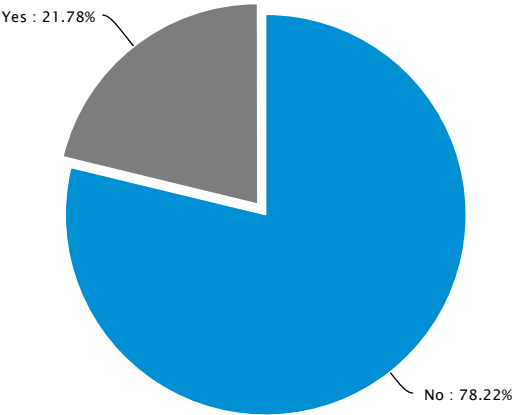

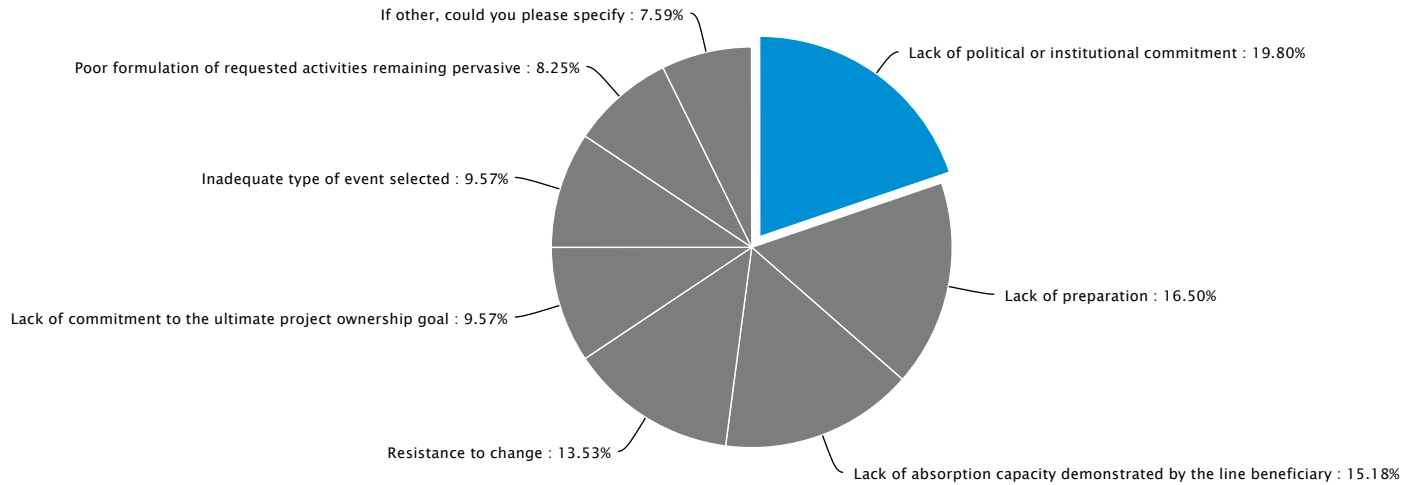

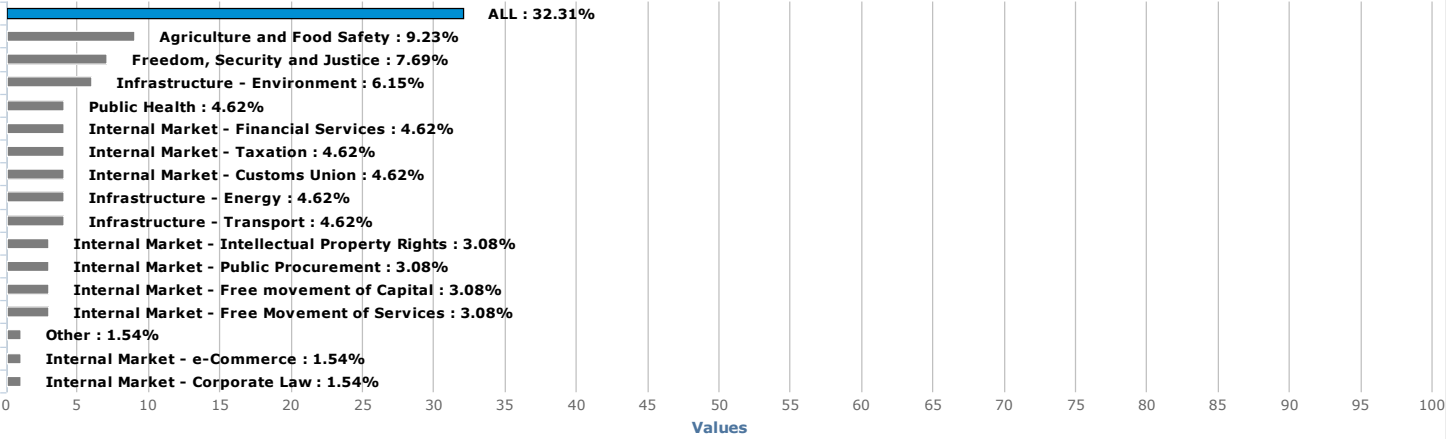

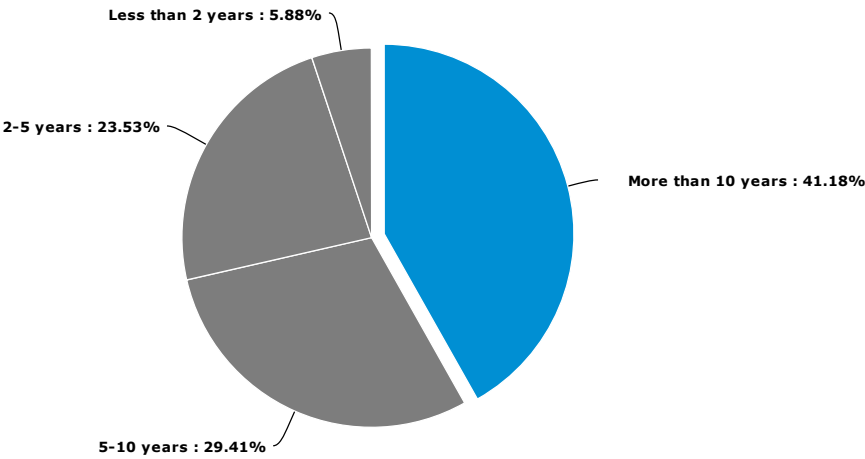

Which of these TAIEX areas (or EU Acquis Chapters) do you deal with?

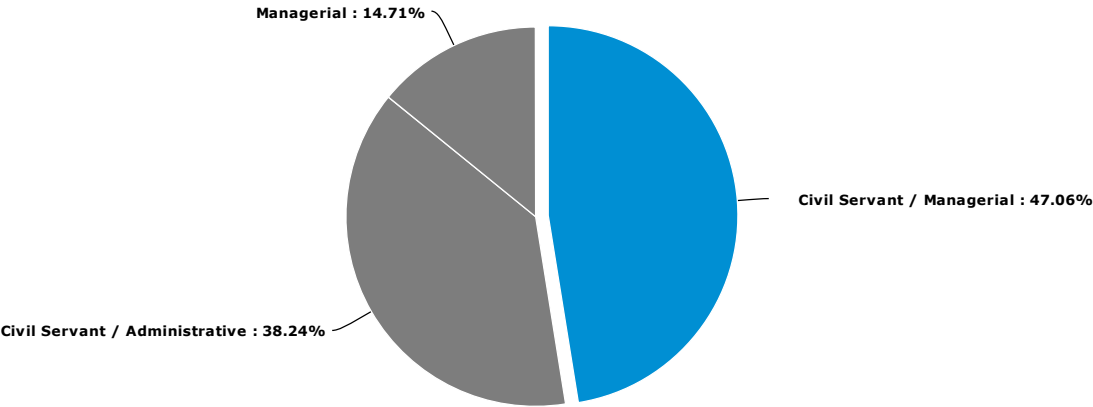

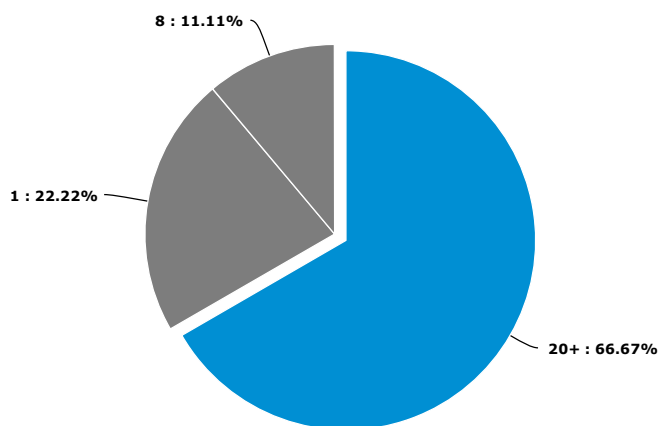
How many TAIEX events requested? : IPA II (2013-2014)



How many TAIEX events requested? : IPA I (2007-2013)

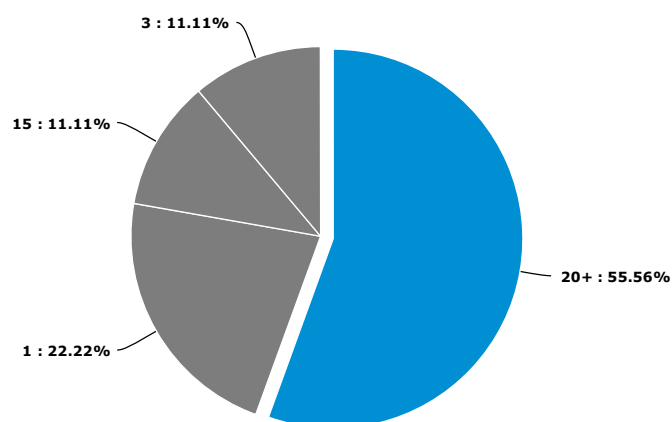

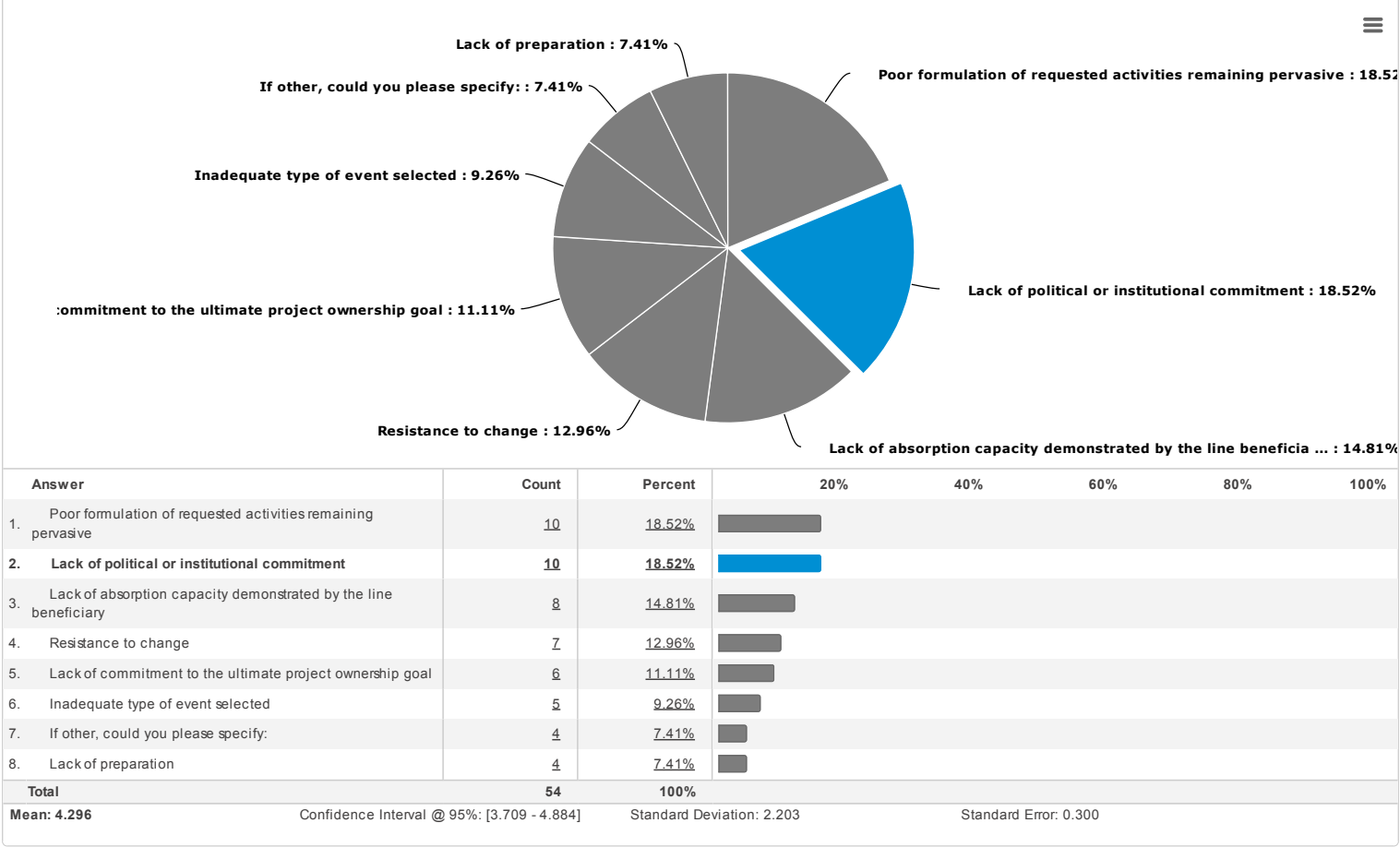


How many events implemented? : IPA I (2007-2013)

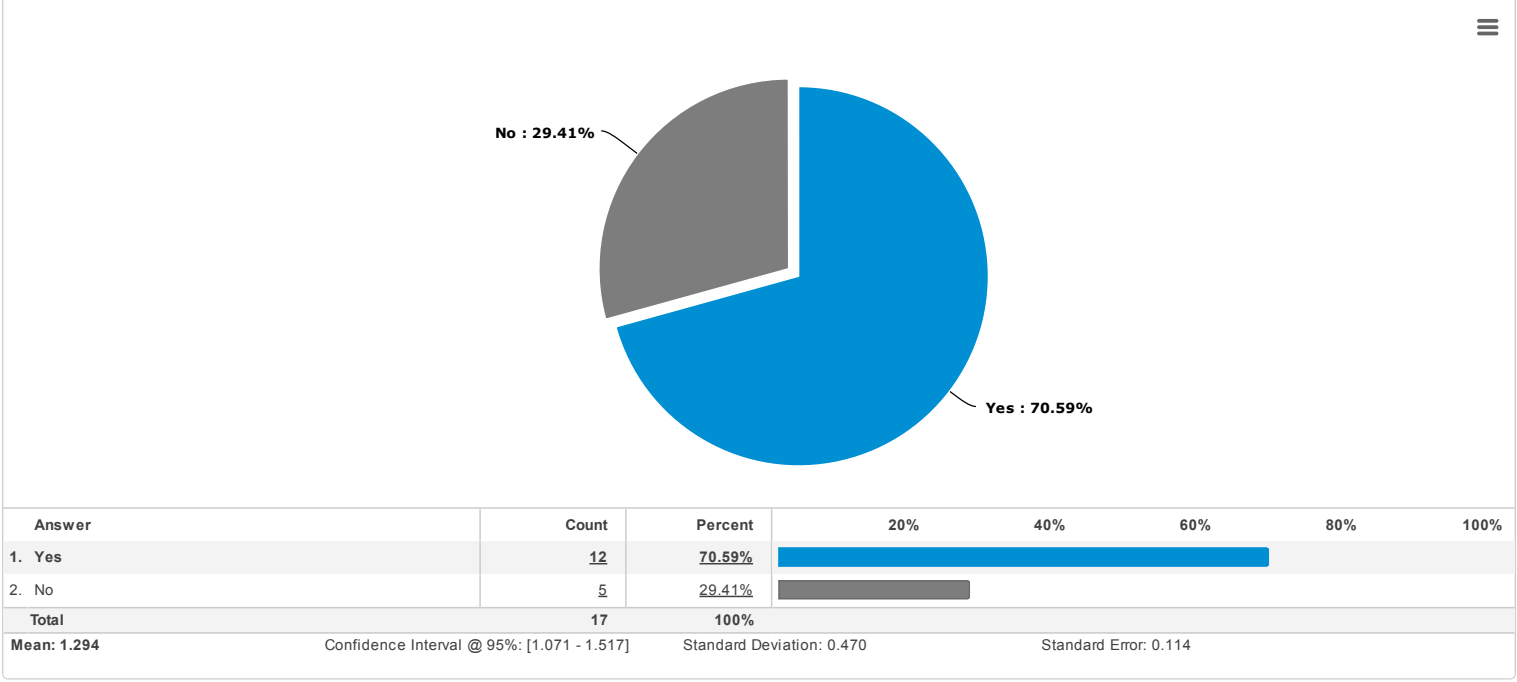

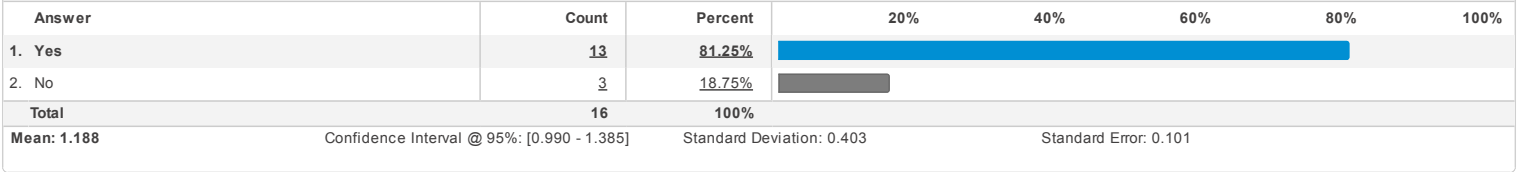

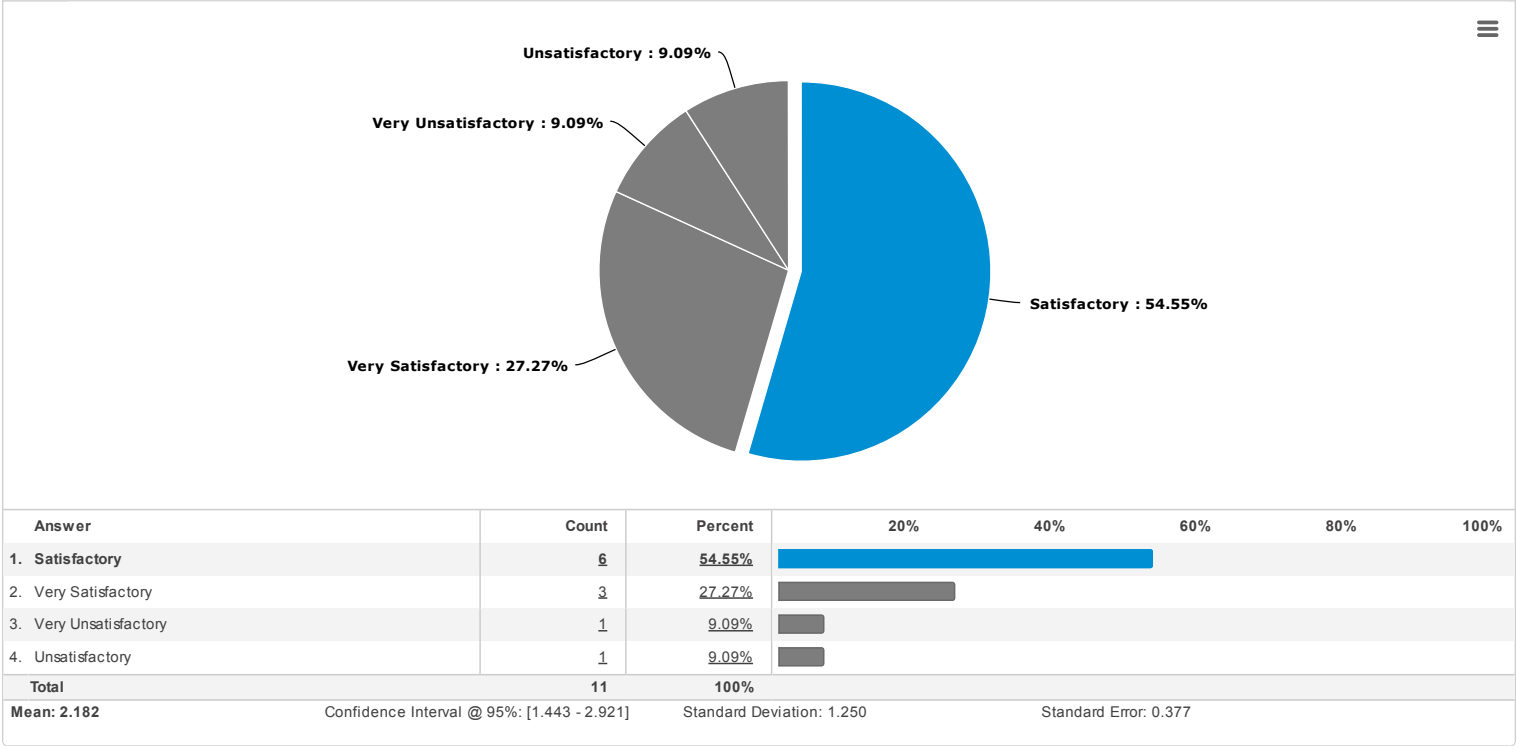

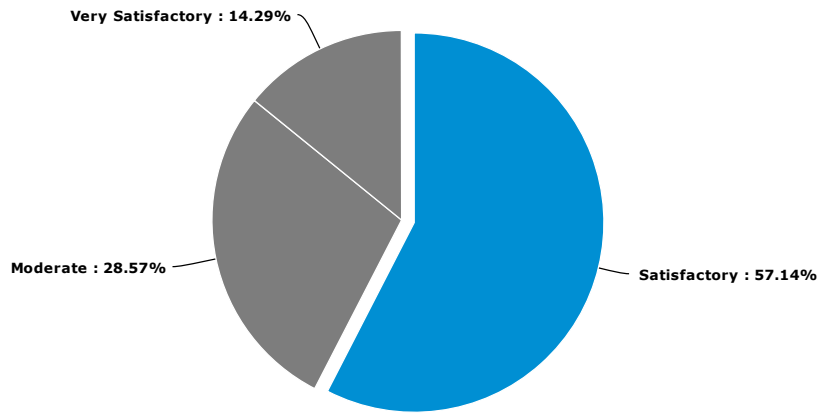

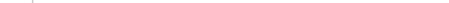

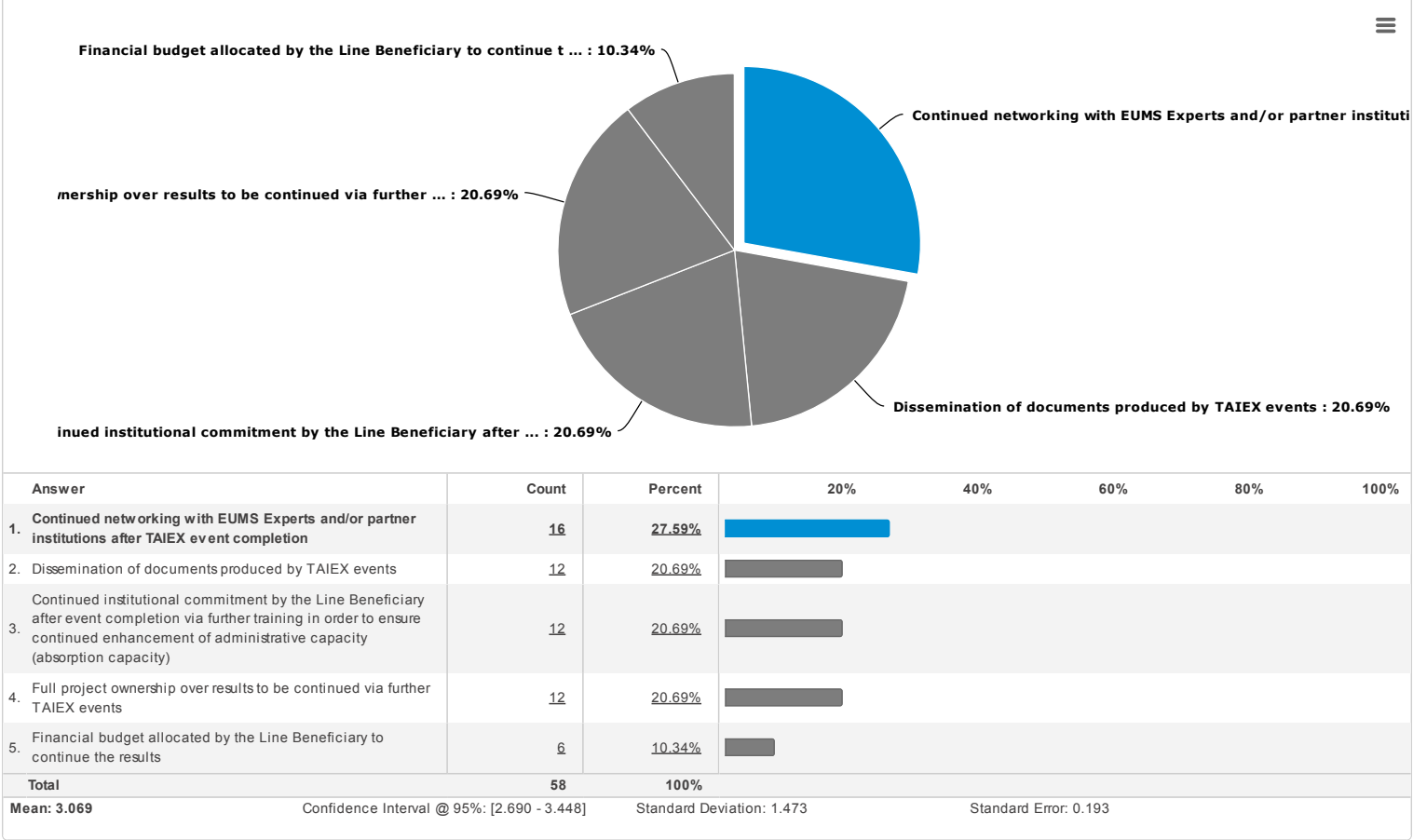

OBJECTIVES

- **Global objective:** to provide the Contracting Authority with relevant findings and conclusions showing the overall relevance of TAIEX, its contribution to the achievement of objectives set out, as well as recommendations to enhance the TAIEX's efficiency and effectiveness.
- **Specific objective:** Assessment of the relevance, value added and cost effectiveness of TAIEX assistance.
- **SWOT Analysis** of the TAIEX instrument.



METHODOLOGY

Key data collection methods used:

- **Comprehensive desk review** of available documentation and literature linked to TAIEX assistance.
- **Face-to-Face interviews** with the relevant units of nine thematic line European Commission Directorate Generals (DG) in Brussels.
- **Telephone interviews** with line beneficiaries in the four selected IPA countries and four European Union Member State (EUMS) National Contact Points (NCPs).
- **Two comprehensive e-Surveys:** 1) with line beneficiaries in the 4 IPA countries, 2) with European Commission's 9 relevant thematic line DGs and 28 EUMS NCPs.



RELEVANCE

- Relevance is particularly high.
 - Support to pre-accession process (approximation, application and enforcement of the EU *acquis*).
 - TAIEX reflects needs of BAs for capacity building and technical assistance in different areas of *acquis*.
 - Quick response and way to address arising needs of BAs, with best expertise and experiences from the EUMS.
- The broad, system-focused design of the TAIEX assistance is ***appropriate*** (needs and priorities of the BAs).



EFFECTIVENESS

- TAIEX contributions to envisaged reforms are almost exclusively positive.
- TAIEX has delivered useful results in beneficiary countries:
 - support through informed strategies, improved legislation, enhanced institutional capacity, modernisation of practices and new models of work, but also behavioural change.
- Evidence of contributions of TAIEX in the progression towards envisaged reform outcomes in different sectors.
- Opportunity for BAs to establish networks, working relations and durable partnerships with EU MS colleagues.



EFFECTIVENESS – cont.

Obstacles to the effectiveness of TAIEX events

- Language as a barrier .
- Lack of absorption capacity of the line beneficiary (over 15% of respondents).
- Lack of political or institutional commitment (19.8%).
- Lack of preparation or resistance to change (13.5%).

Complementarity/coherence with other donor and EU-funded programmes and instruments

- The instrument is complementary to other interventions.
- Mechanisms to ensure minimisation of overlaps.



EFFICIENCY

- TAIEX management arrangements are in place for an effective implementation of activities.
- Cost-effectiveness of TAIEX is very difficult to assess
- Support to legislation development, learning about new modalities of work and introducing new quality standards: cost-effective, value at low costs.
- Study visits bring value for money.



EFFICIENCY – cont.

- Readily available monitoring data on various perspectives of TAIEX assistance.
- Continuous improvement of the IT system.
- TAIEX contracting process remains too long for the sometimes rapidly-evolving beneficiary needs in a transition country environment.
- Concerns exist with the logistics.
- TAIEX Management System's operation almost entirely positive.
- Communication is considered adequate.
- Application process is functional to large extent.
- The duration (five days maximum) is generally sufficient and it is in line with the purpose of TAIEX technical assistance.



EFFICIENCY - cont.

Appropriateness of the TAIEX Instrument to Needs (from an implementation perspective)

- Management structures and approaches used by TAIEX are appropriate.
- Each type of event has its specific use at a specific stage of the development/reform process.
 - **Expert missions** and workshops useful for legislation/policy development.
 - **Workshops** are suitable to clarify general topics to a broader audience.
 - **Study visits** useful for implementation of new mechanisms or models brought in by the legislation/policies.
- Value and purpose of study visits is understated/underestimated.



EFFICIENCY - cont.

Reporting

- Experts' reporting- area for improvement

Communication and Visibility activities

- TAIEX assistance contributing to enhancing the visibility of EU funding among public institutions.
- TAIEX increasingly popular and visible instrument, filling in the gaps.



IMPACT

- The effects of TAIEX can be best considered in conjunction with other forms of EU assistance
- No information available on the extent to which achievements made to date – via TAIEX - have influenced, or will influence changes on reforms within the EU accession process are yielding results.
- Important contributions in view of influencing the enabling environments for such changes in the country
 - improved legislation and better informed strategies.
 - a more functional institutional framework.
 - strengthened capacities to deliver the strategic priorities in various segments of EU accession.
 - overall modernisation of public administration.
 - positively affecting country administrations by helping them to become more professional and client oriented.
 - institutional changes and corporate culture.



SUSTAINABILITY

- Adopted legislation and new mechanisms.
- TAIEX instrumental to supporting BAs to adequately implement these new mechanisms.
- Administrative and organisational structures in place.
- Needs-based activities bringing sustainable results with them .
- Outcomes of TAIEX assistance will continue to produce constructive effects after the end of EU funding.
- Administrative cultures have evolved and sustainable behavioural change has occurred.
- Networking and improved know-how of public servants.
- Hindering factors for sustainability:
 - high staff and low language capacities.
 - Sustainability depends on development policy of national institutions and on their administrative and financial capacities.

SWOT ANALYSIS

Strengths:

- Relevance.
- Participatory approach to programming.
- Expertise.
- Mobilisation.
- Synergy.
- Flexible implementation framework.

Weaknesses :

- Fragmentation of support.

Opportunities :

- Sequencing of TAIEX assistance.
- Knowledge management and learning.
- Complementarity .

Threats:

- Deteriorating situation in individual countries or in the region.
- The late communication of logistical arrangements to the participants.
